Subject: Levy the increase of Basic Customs Duty on Industrial laundry equipment

Respected Sir,

Greetings from MAIT, the apex body of the electronics hardware manufacturing sector in India!

We are writing this to request you to accept our recommendation to levy the increase of Basic Custom Duty from 10% to 20% on Industrial laundry equipment of capacity of more than 10 Kg to promote the domestic manufacturing of 40-45% of components used in these finished goods.

Impact of Increase of BCD:

- 1. The SMEs and MSMEs will benefit from the increase in duty as 40-45% of components used in Finished Goods will be outsourced to them. It will in turn help strengthen Indian economy.
- 2. 40-45% of components used in manufacturing laundry equipment are outsourced from local manufacturers, which are bought out components and job work components. Hence, when import duty is increased there will be a shift from foreign manufacturers to Indian domestic manufacturing.
- 3. It will help in providing a much-required boost to domestic manufacturing of the IT Hardware goods as the idle capacities capable of manufacturing populated printed circuit boards will be utilized.
- 4. This increase will help in developing required ecosystem and component industry for the domestic IT Hardware manufacturing which will also have multiplier effect.
- 5. Indigenization of components will make the goods manufactured in the country very competitive in the global market, thereby boosting the exports as well.
- 6. It will also provide an additional revenue to the Government of India.
- 7. This will also help in curbing the imports of components from China.
